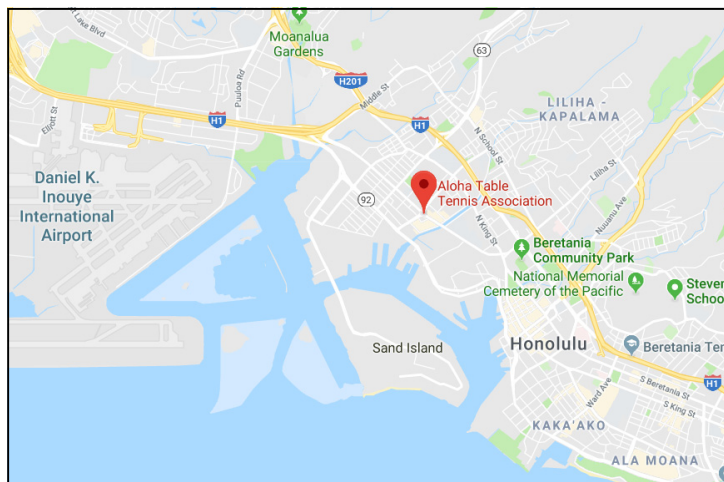
Tournament Format:

- All matches are best of 5 games. Each game is to 11 points, win by two points. Subject to change due to time.
- Maximum of 24 participants in each Singles event. Subject to change.
- Single & Double events are Group Round Robins, followed by single elimination.
- Depending on turnout, events are subject to change. Participants will be notified asap of any changes.
- A participant may enter both doubles events, provided that the combined ratings don't exceed that event total.
- Junior Singles event - Depending on turn out, we may divide the Juniors into two groups by skill level, A & B.
- Open Women's Singles "Top Cat" - Participants must be rated **at least 1000** to enter this Open Singles event.
- Open Men's Singles "Top Dog" - Participants must be rated **at least 1500** to enter this Open Singles event.
- For participants with no USATT rating, self rating will be allowed, but needs to be verified by Tournament Directors. Each participant will be assigned an ATTA rating by Tournament Director and Committee.

Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement ("Agreement")

- 1. IN CONSIDERATION of being permitted to participate in any way at Aloha Table Tennis Association and any of their events, I and/or my minor child, our personal representatives, assigns, heirs, and next of kin:
- 2. ACKNOWLEDGE, agree, and represent that I and/or my minor understand the nature of Table Tennis Activities and that I and/or my minor child are qualified, in good health, and in proper physical condition to participate in such Activity. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or my minor child will immediately discontinue further participation in the Activity.
- 3. FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH, HARASSMENT, EXPOSURE TO INAPPROPRIATE CONDUCT AND LANGUAGE ("RISKS"); (b) these Risks and dangers may be caused by me and/or my child's own actions, or inaction, or the actions or inaction of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SEVERE SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or my minor child incur as a result of my participation in the Activity.
- 4. HEREBY ACCEPT AND ASSUME ALL SUCH RISKS, KNOWN AND UNKNOWN, AND ASSUME ALL RESPONSIBILITY FOR THE LOSSES, COSTS, AND/OR DAMAGES FOLLOWING SUCH INJURY, DISABILITY, PARALYSIS, OR DEATH, EVEN IF CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW;
- 5. HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE ALOHA TABLE TENNIS ASSOCIATION, their respective administrators, directors, agents, officers, officials, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I and/or my minor child, or anyone on my and/or my minor child's behalf, makes a claim against any of the Releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.
- 6. ANY AND ALL CLAIMS, controversies or disputes arising out of or relating to this AGREEMENT, or the breach thereof, which remain unresolved after direct negotiations between the parties, SHALL FIRST BE SUBMITTED TO CONFIDENTIAL MEDIATION in accordance with the RULES, PROCEDURES, AND PROTOCOLS FOR MEDIATION OF DISPUTES OF Dispute Prevention & Resolution, Inc., then in effect. IF ANY ISSUES, CLAIMS OR DISPUTES REMAIN UNRESOLVED AFTER MEDIATION CONCLUDES, the parties AGREE TO SUBMIT ANY SUCH ISSUES TO BINDING ARBITRATION before one arbitrator in accordance with the Rules, Procedures, and Protocols for Arbitration of Disputes of Dispute Prevention & Resolution, Inc., then in effect. THE PARTIES FURTHER AGREE THAT THE AWARD OF THE ARBITRATOR(S) IS BINDING UPON THE PARTIES AND THAT JUDGEMENT UPON THE AWARD RENDERED MAY BE ENTERED IN ANY COURT OF COMPETENT JURISDICTION.
- 7. I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
- 8. I CONSENT TO HAVE MY PHOTOGRAPH (still or motion) USED FOR ANY ALOHA TABLE TENNIS ASSOCIATION MEDIA PURPOSES (including but not limited to: website, fliers, banners, new media, internet).
- 9. I UNDERSTAND THAT Aloha Table Tennis Association, owners and lessors of premises are NOT RESPONSIBLE for theft, damage, or any valuables left in vehicles on or around premises.
